Paying Your Plan Premium:

If we determine that you owe a late enrollment penalty (or if you currently have a late enrollment penalty), we need to know how you would prefer to pay it. You can pay by mail or Electronic Funds Transfer (EFT) each month. You can also choose to pay your premium by automatic deduction from your Social Security or Railroad Retirement Board (RRB) benefit check each month. If you are assessed a Part D-Income Related Monthly Adjustment Amount, you will be notified by the Social Security Administration. You will be responsible for paying this extra amount in addition to your plan premium. You will either have the amount withheld from your Social Security benefit check or be billed directly by Medicare or the RRB. **DO NOT** pay BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier the Part D-IRMAA.

People with limited incomes may qualify for Extra Help to pay for their prescription drug costs. If eligible, Medicare could pay for 75% or more of your drug costs including monthly prescription drug premiums, annual deductibles, and co-insurance. Additionally, those who qualify will not be subject to the coverage gap or a late enrollment penalty. Many people are eligible for these savings and don't even know it. You can also apply for Extra Help online at www.socialsecurity.gov/prescriptionhelp.

If you qualify for Extra Help with your Medicare prescription drug coverage costs, Medicare will pay all or part of your plan premium. If Medicare pays only a portion of this premium, we will bill you for the amount that Medicare doesn't cover. If you don't select a payment option, you will get a bill each month.

If you currently have health coverage from an employer or union, joining BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier could affect your employer or union health benefits. You could lose your employer or union health coverage if you join BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier. Read the communications your employer or union sends you. If you have questions, visit their website, or contact the office listed in their communications. If there isn't any information on whom to contact, your benefits administrator or the office that answers questions about your coverage can help.

Attestation of Eligibility for an Enrollment Period

Typically, you may enroll in a Medicare Advantage plan only during the annual enrollment period from October 15 through December 7 of each year. There are exceptions that may allow you to enroll in a Medicare Advantage plan outside of this period.

By completing this enrollment application, I agree to the following:

BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier is a Medicare Advantage plan and has a contract with the Federal government. I will need to keep my Medicare Parts A and B. I can be in only one Medicare Advantage plan at a time, and I understand that my enrollment in this plan will automatically end my enrollment in another Medicare health plan or prescription drug plan. It is my responsibility to inform you of any prescription drug coverage that I have or may get in the future. Enrollment in this plan is generally for the entire year. Once I enroll, I may leave this plan or make changes only at certain times of the year when an enrollment period is available (Example: October 15 - December 7 of every year), or under certain special circumstances.

BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier serves a specific service area. If I move out of the area that BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier serves, I need to notify the plan so I can disenroll and find a new plan in my new area. Once I am a member of BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier, I have the right to appeal plan decisions about payment or services if I disagree. I will read the Evidence of Coverage document from BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier when I get it to know which rules I must follow to get coverage with this Medicare Advantage Plan. I understand that people with Medicare aren't usually covered under Medicare while out of the country except for limited coverage near the U.S. border.

I understand that beginning on the date BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier coverage begins, I must get all of my health care from BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier, except for emergency or urgently needed services or out-of-area dialysis services. Services authorized by BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier and other services contained in my BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier Evidence of Coverage document (also known as a member contract or subscriber agreement) will be covered. Without authorization, **NEITHER MEDICARE NOR BLUEMEDICARE CLASSIC, BLUEMEDICARE CLASSIC PLUS OR BLUEMEDICARE PREMIER WILL PAY FOR THE SERVICES.**

I understand that if I am getting assistance from a sales agent, broker, or other individual employed by or contracted with BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier, he/she may be paid based on my enrollment in BlueMedicare Classic, BlueMedicare Classic Plus or BlueMedicare Premier.
